Timed Events: Two rounds – Top 8 from 1st go will perform during rodeo (**JR BARREL RACERS MUST BE UNDER 30 SECONDS, JR POLE BENDERS UNDER 45 SECONDS TO ADVANCE TO PERFORMANCE**) **TOP 8 IN JR. BARRELS & JUNIOR POLES WILL BE UP IN THE PERFORMANCE ON SATURDAY. LADIES BARRELS AND POLES - TOP 8 WILL BE UP ON SUNDAY.**

Roping Events: Roping events are on a 3-head average. **Both Arenas will be used in slack.** All contestants will rope 2 head in slack. **Top 10 TEAM ROPING TEAMS will advance to the short go. Top 8 will advance to short go in OPEN CALF ROPING, RANCH CALF ROPING, STEER ROPING, and BREAKAWAY ROPING EVENTS.**

Team Events: Each contestant must complete an entry form and sign a waiver. All team members must agree to participate or entry fees will be forfeited.

Rough Stock Events: 15 or more entries = 1 head / 14 or less entries = 2 head. Rough stock events are **open to Wyoming Residents.** Steer wrestling limited to Johnson, Sheridan & Campbell County residents only.
