LIVESTOCK OWNER'S CERTIFICATE

The undersign certifies that, to the best of his/her/its knowledge as of the date of shipment or delivery, none of the livestock shipped to or delivered to the Johnson County Junior Livestock Sale will be, on such date adulterated within the meaning of the Federal Food, Drug & Cosmetic Act (i.e., none of the market beef, goats, sheep, swine, poultry, or rabbits will have been fed any feed containing protein derived from mammalian tissue, e.g. meat and bone meal, as that term is defined in 21 CFR 589.2000 and none of the livestock will have an illegal level of drug residues, to the best of my knowledge). This certificate shall remain in full force and effect until revoked in writing by the undersigned seller and such revocation is delivered to the Johnson County Sale Committee and is delivered to the slaughter establishment. ALL LIVESTOCK MARKETS AND PACKING PLANTS WILL REQUIRE THIS CERTIFICATE. A SEPARATE CERTIFICATE WILL BE REQUIRED ON INDIVIDUAL BRANDS. THESE CERTIFICATE WILL BE REQUIRED, EFFECTIVE APRIL 1ST, 2001. Examination by plant personnel of the dentition will be the final determination of age at the slaughter establishment.

I have entered the animal listed above in the 2021 Junior Livestock Sale. I have read and understand the Junior Livestock Sale Show Rules. I have read the above conditions pertaining to the Federal Food, Drug, and Cosmetic Act.

I understand and agree to the 8% commission charged by the Junior Livestock Sale Committee for services rendered in the administration of the Junior Livestock Sale. I am also aware of the possible 6% commission reduction, effectively reducing the commission to 2%, as consideration for services in kind for my attendance at the Junior Livestock Sale Committee Meeting and the completion of the participation requirements. I understand that failure to complete all the requirements of the Junior Livestock Sale may jeopardize participation in future Johnson County Junior Livestock Sales.
