**PARENT CHILD TEAM ROPING**.... Parents Name \_\_\_\_\_

- 1) Must be parent or legal guardian of child – if child has no such guardian a partner will be drawn from among the committee.
- 2) Parent is not limited to one child.
- 3) Three-loop rule applies for age group 13-16 / 60 second rule for 12 and under.
- 4) Top six teams from each division will rope one head at the Johnson County Rodeo
- 5) Fastest time on two head wins the buckle.
- 6) Parents do not pay for entries nor win awards.

**RIBBON ROPING** – Must be boy/girl team - Runner and roper must enter – Both pay entry fee – catch as catch can.

**TEAM ROPING** (3 loop rule) if partners are different age group, they must rope in the oldest age division.

**CALF ROPING**.... (Horse used) Age 9-16 \_\_\_\_\_

**BREAKAWAY ROPING**.... Age 12 & under \_\_\_\_\_ Steer - 60 second time limit, 3 legal head catch

Age 13-16 \_\_\_\_\_ Calf - 2 loops, no 2<sup>nd</sup> rope, rebuild 2<sup>nd</sup> loop, barrier used.

**DUMMY ROPING**.... Cannot enter if entered in any other roping event – at least 2 swings before you throw - 2 attempts.

**CHUTE DOGGIN**.... (No horse used) ... Age 12-16 \_\_\_\_\_

**GOAT TAIL TYING**.... (No horse used) ... cannot enter if entered in Goat Tying

**RIBBON RACE**.... State partners name on blank – Both partners must enter – If partners are in different age divisions, they must run in oldest age division.

All events must have five participants, if not fees will be refunded.

ALL ENTRIES MUST HAVE SIGNED JCJR WAIVER

To be eligible to enter the Johnson County Youth Rodeo you must meet one of the requirements (mark all that applies)

\_\_\_\_ Enrolled in Johnson County Schools

\_\_\_\_ Member of Johnson County 4-H and completed their project.

\_\_\_\_ If child is not old enough for JCS or JC 4-H but has an older sibling that does, said child would then qualify.

\_\_\_\_ If parent or legal guardian is eligible for Johnson County Fair and Rodeo the child is eligible for the Johnson County Youth Rodeo.

*\*\*\*\*\*Johnson County Youth Rodeo Board has final decision of eligibility\*\*\*\*\**

To be eligible for an event you must be the required age by August 1, 2023. Youths older than 16 are not eligible.

- *In roping events with steers there are 3 legal head catches: both horns, neck or ½ head*
  - *Contestants may only enter each event once.*
  - *Six places will be awarded in each event - \$15, \$13, \$11, \$8, \$6 and \$5*
